Congressman Bacon's visit to Immanuel Pathways in Omaha



The Immanuel Advocacy and PACE® Teams met with Nebraska's 2nd District Congressman Bacon on Monday, November 3. While we had him, we had specific questions about a new law that was passed in January 2025, the Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act. This law would specifically help connect veterans to a PACE® program. This new law mandates that the U.S. Secretary of Veterans Affairs "seek to enter into an agreement with the PACE® program operating in that area for the furnishing of such services". Congressman Bacon and his staff are

committed to following up with the Secretary and our local VA leadership regarding this law after the government reopens.

Federal Government Shutdown

The longest Federal Government Shutdown continues, but it could reopen very soon. On Sunday November 9, a compromise was reached in the U.S. Senate. The Senators moved a different continuing resolution to reopen the government through January 30 and provide funding for some agencies, including SNAP, through the end of next September. The other side of Congress, the House, must agree, and that vote to agree may happen this week.

Next Steps for Immanuel Advocacy

Nebraska - Affordable Housing

Nebraska Affordable Housing interim study hearings in the legislature occurred on Oct. 24. There were many attendees who showed a lot of interest in LR86 regarding affordable and accessible housing. Several people shared they were seniors or experiencing a mental or physical disability and expressed the importance of accessibility. More concrete ideas for bills in 2026 look like mandating accessible housing in new builds or requiring a certain percentage. The committee received a lot of input from several municipalities about LR146 which focuses on community development law, though concrete bill ideas failed to arise from that discussion.
