


October 2025 Monthly Newsletter

Welcome to October and the federal government shutdown. The status of the shutdown, the negotiations or the lack thereof, and votes to try to end the shutdown are reported nonstop. We hope you find a variety of news outlets to get your news.

The Ad Fontes Media Chart is one way to see the many different news outlets and a general idea of how politically biased your news source could be. This chart shows the outlets along a continuum of the divide we all live in: left and right. It also measures value and reliability. Every news source is at least a little biased one way or another. There is also an interactive chart where Ad Fontes rates individual stories and opinion pieces from the source. You get one free search on their website unless you have a subscription. You can also download a free static chart of the largest media outlets. Check it out if you're interested. They include websites, articles, TV, video, podcasts, and audio.

Federal Government Shutdown

Immanuel leadership expressed this week that while a shutdown can disrupt many government areas, Immanuel will continue to provide stability for you and those we serve. We do not anticipate direct impacts to our work regardless of potential delays of federal payments. No recent shutdown has lasted more than 35 days, and no matter the length of this shutdown, Immanuel's mission continues. We will not allow a funding lapse in Washington to interrupt the care and stability we provide daily.



Most news sources report that crucial health programs will continue to operate during the federal government shutdown. Still, many services will halt or be significantly less efficient as staffers are furloughed, based on contingency plans for the U.S. Department of Health and Human Services (HHS). Many protected activities during a shutdown are ensured through the federal Antideficiency Act, which allows for voluntary service of federal employees in emergencies dealing with the "safety of human

life or the protection of property." Staffers across various agencies dealing with mandatory activities like Medicare and Medicaid will be retained.

The Housing and Urban Development agency (HUD) is somewhat different. Housing programs can face disruption during a shutdown. However, HUD has been proactively front-filling accounts to ensure payments continue. This precaution provides additional protection for our affordable communities.

Nebraska - Medicaid Updates

On Sept. 15, our advocacy and PACE® teams met with Drew Gonshorowski, the new Nebraska Medicaid and Long-Term Care director. We strategized options to increase Medicaid eligibility and/or reimbursement rates through the regulatory process. Mr. Gonshorowski was friendly and stayed for as long as we needed. He also said he'd volunteer to play some music with his wife for any of our communities. Mary Parker is already on it to sign him up. The negotiations for an increase in eligibility will continue, and most likely a bill will be introduced in the 2026 Legislative session.

Nebraska - Legislative Interim Studies

Oct. 16, 1:30 p.m. - The Health and Human Services Committee will study two legislative resolutions:

- 1. <u>LR232</u> examines regulatory restrictions and opportunities in medical education to strengthen the **medical workforce** in rural and other underserved areas, and
- LR224 examines the effectiveness of programs addressing health-related social needs, which are unmet adverse social conditions that contribute to poor health, including food insecurity, unemployment, and housing instability.

Oct. 24, 10 a.m. - The Urban Affairs Committee will hear two studies:

- 1. LR86 identifies and examines the state of affordable and accessible housing in Nebraska, and
- 2. <u>LR146</u> examines the intersection of tax increment financing and **affordable housing** in the State of Nebraska. You can <u>watch it live</u> or later once the video is posted to the Unicameral website.

Nov. 7, 9:30 a.m. - The Health and Human Services Committee will study **Medicaid.** LR188 will examine the significance of the state financial partnership with the federal government in delivering health services through the Medicaid program. This appears to focus on those under age 64, but we will tune in.

Elections

Before we know it, another national general election will held in November 2026 and state primaries in the spring. Local elections are happening now in Iowa. The Nebraska and Iowa State legislatures will meet between now and the 2026 elections. Changes to voting laws may be proposed and may occur. As always, we'll keep you posted.
